Registration Terms and Conditions

This agreement (the “**Terms and Conditions**”) is made between the Pulmonary Vascular Research Institute (“**we**”, “**us**”, “**our**”) whose registered address is at 5 Tanner Street, London, United Kingdom, with registered company number 5780068 and registered charity number 1127115 and the PVRI member named in the registration form (“**you**”, “**your**”) for the registration to attend the PVRI’s 15th Annual World Congress (the “**Event**”).

Please read the Terms and Conditions carefully before making any orders with us and contact us or a legal advisor if you have any questions.

Please note, nothing under these Terms and Conditions will affect your legal rights as a consumer.

By registering for the Event with us, you confirm that you have read, understood and agree to the Terms and Conditions and that you agree to be bound by them. If you do not agree to be bound by all of the Terms and Conditions, please do not proceed and please do not register for the Event.

1 Registration:

- 1.1 By registering for and/or attending the Event, you agree to be bound by, and comply with, these Terms and Conditions. It is your responsibility to read and understand these Terms and Conditions.
- 1.2 The Event will be provided as far as reasonably possible in accordance with its description as published on our website and subject to the Terms and Conditions. We may correct any typographical or other errors or omission in any description, promotional literature, price lists or other documents relating to the Event without liability to you.
- 1.3 Payment of the applicable registration fee for the Event will be taken in full at the time of booking.
- 1.4 During the registration process, we will ask you for your payment details. You can pay via debit or credit card or by electronic bank transfer. By giving us your payment details, you confirm that the card being used is yours. Your card and payment details are processed by us and our online payment provider, Global Payment, in accordance with our Privacy Notice [here](#). All card payments are subject to authorisation by your card issuer.
- 1.5 Registration will not be confirmed until the completed form and the correct payment is received and processed by us. On or after our acceptance of your order for the Event, we will send you a confirmation email.
- 1.6 You should wait for such confirmation email from us before committing to other travel arrangements.
- 1.7 Travel and accommodation costs are not included in the registration fee. You are responsible for making your own travel and accommodation arrangements.
- 1.8 You are responsible for taking appropriate insurance coverage in connection with your attendance at the Event. Where you are travelling from outside of the host country to attend, appropriate travel insurance should be purchased independently and in advance of any travel or travel bookings.
- 1.9 You confirm that you will comply with the instructions, recommendations and applicable terms and conditions of any third party who provides the venue or other facilities for the Event.

- 1.10 If you wish to make changes to the names and details of the attendees for the Event, please notify us as soon as practicable by email to admin@pvrinstitute.org.

2 Privacy:

- 2.1 You may be asked to provide contact details of when registering for the Event. All personal data will be processed in accordance with our Privacy Notice which you can view [here](#).
- 2.2 The Event may involve third parties in delivery and we may supply basic registration information about you to them in order for them to assess the audience and make adjustments to the content. This information will be supplied with express instructions that it cannot be used for marketing purposes.

3 Changes to the Event

- 3.1 We reserve the right, in our sole discretion, to change the format, content or timing of the Event programme, the identity of any speakers or exhibitors, or venue for any reason and without liability to you, provided that the Event, as altered, is similar to the Event as originally advertised. For the avoidance of doubt, in these circumstances, we will not refund you for any proportion of the registration fee or otherwise be held liable for any other costs or expenses incurred by you in connection with the Event.

4 Cancellation of your registration:

- 4.1 You have a legal right to cancel the Contract for your Event booking with us (under the Consumer Contracts Regulations 2013) at any time up until 14 working days after our acceptance of your booking ("**Cancellation Period**"). If you cancel your booking within the Cancellation Period, then we will refund the registration fee in full.
- 4.2 If you cancel after the Cancellation Period as a result of Covid-19 government restrictions in your country that prevent you from travelling to the host country, but the Event itself is not cancelled by us, we may at our discretion offer to carry over your registration to the following Annual World Congress at no additional cost to you ("**Deferral**"). If we choose not to offer, or you do not wish to accept the Deferral of your registration, then we will refund the registration fee for the booking less a 20% cancellation fee.
- 4.3 If you cancel after the Cancellation Period, for any other reason, we may at our discretion offer Deferral of your registration. If we choose not to offer, or you choose not to accept our offer of Deferral in this instance, you will not be entitled to a refund of the registration fees.
- 4.4 If you book within 14 days of the Event, you give your permission for us to begin work in relation to your registration, and if you cancel before the Event then we will refund the registration fee minus reasonable costs incurred.
- 4.5 Please remember that cancelling your registration does not automatically cancel your hotel and travel arrangements. You are responsible for cancelling your own hotel and travel reservations.
- 4.6 If you wish to cancel your registration for the Event, please notify us as soon as practicable by sending an email to admin@pvrinstitute.org. You may use our [cancellation form](#) to confirm your cancellation in writing.

5 Cancellation of the Event by us:

- 5.1 Whilst every attempt is made to ensure that events run as planned, we reserve the right to cancel an event for any reason, including for lack of demand, the unavailability of any speaker, facilities or venue, or the impact of any government decision in any country that results in us being unable to host the Event. We will notify you of any cancellation as soon as practicable.

- 5.2 In the event of cancellation by us, you will be offered a choice of a full refund of the registration fee, or Deferral of your registration.

6 Liability

- 6.1 Nothing in the Terms and Conditions excludes or limits our liability for:
- a) death or personal injury caused by our negligence;
 - b) fraud or fraudulent misrepresentation; and
 - c) breach of the terms implied by section 13 to 15 of the Sale of Goods Act 1979 (description, satisfactory quality, fitness for purpose and samples).
- 6.2 Please note that we will not be liable or responsible for any failure to perform, or delay in performance of, any of our obligations under the Terms and Conditions that is caused by circumstances outside our reasonable control that directly or indirectly delays or prevents our timely performance.
- 6.3 In the event of cancellation under Clauses 4 or 5, we will not be liable for (excluding the registration fee where applicable) any costs incurred as a result of cancellation including, but not limited to, any travel or accommodation costs, and we will not be obliged to offer any compensation to you for any disappointment suffered or for any other indirect or consequential losses, costs or damages incurred by you as a result of cancellation.
- 6.4 We exclude all liability that we have not expressly accepted in the Terms and Conditions, including liability for indirect or consequential loss or damage.

7 Warranties

- 7.1 We will perform our obligations under the Terms and Conditions with reasonable care and skill.
- 7.2 We warrant that the Event will comply with its description.

8 Other important terms

- 8.1 We may transfer our rights and obligations under these Terms and Conditions to another organisation. We will notify you in writing or on the website if this happens, but this will not affect your rights or our obligations under the Terms and Conditions.
- 8.2 You may only transfer your rights or your obligations under these Terms to another person if we agree in writing.
- 8.3 This contract is between you and us. No other person shall have any rights to enforce any of its terms, whether under the Contracts (Rights of Third Parties Act) 1999 or otherwise.
- 8.4 Each of the paragraphs of these Terms and Conditions operates separately. If any court or relevant authority decides that any of them are unlawful or unenforceable, the remaining paragraphs will remain in full force and effect.
- 8.5 If we fail to insist that you perform any of your obligations under the Terms and Conditions, or if we do not enforce our rights against you, or if we delay in doing so, that will not mean that we have waived our rights against you and will not mean that you do not have to comply with those obligations. If we do waive a default by you, we will only do so in writing, and that will not mean that we will automatically waive any later default by you.
- 8.6 These Terms and Conditions are governed by English law. This means registration of the Event, and any dispute or claim arising out of or in connection with it will be governed

by English law. You and we both agree to that the courts of England and Wales will have exclusive jurisdiction.
